My project operates on a strictly non-profit and philanthropic basis. I do not seek external funding; my contribution is entirely "in-kind", consisting of:

- The full availability of my private office, laboratory equipment, and facilities.
- My professional time and expertise as a senior engineer, provided on a **voluntary and pro-bono basis**.
- This model ensures my total independence and guarantees that there are no financial barriers for those seeking pastoralist education and guidance through my office.
